



# Zahtjevi u svezi prebivališta za primanje roditeljskih plaćanja

Nositelji partner provisional ili interdependency visas mogu primiti niže navedena plaćanja ako se privremeno nalaze izvan Australije iz prihvaćenih opravdanih razloga.

- Family Tax Benefit
- Parental Leave Pay ili Dad and Partner Pay, ili
- Double Orphan Pension.

No međutim, nositelji temporary protection visas ne mogu primiti isplate dok se iz bilo kojeg drugog razloga nalaze izvan Australije.

## Family Tax Benefit

Da biste imali pravo na Family Tax Benefit Part A i Part B, morate zadovoljiti zahtjeve u svezi prebivališta. Morate živjeti u Australiji i

- imati australsko državljanstvo
- imati stalnu vizu
- imati special category visa, ili
- imati određeni tip privremene vize, na primjer partner provisional, interdependency ili temporary protection visa.

Vaše dijete mora također ispunjavati uvjete prebivališta ili živjeti s vama.

Vi i dalje morate ispunjavati uvjete prebivališta sve dok primete ovu vrstu plaćanja.

## Paid Parental Leave scheme

Da biste imali pravo na Parental Leave Pay morate ispunjavati uvjete prebivališta od dana kada je vaše dijete rođeno ili je došlo pod vašu primarnu skrb, do zadnjeg dana primanja ove vrste plaćanja.

Da biste imali pravo na Dad and Partner Pay morate ispunjavati uvjete prebivališta za svaki dan za koji primete ovu vrstu plaćanja.

Kada se vaše dijete rodi ili dođe pod vašu primarnu skrb, vi morate živjeti u Australiji i:

- imati australsko državljanstvo
- imati stalnu vizu
- imati special category visa

- imati određeni tip privremene vize, na primjer partner provisional, interdependency ili temporary protection visa.

## Parenting Payment

Da biste imali pravo na Parenting Payment, morate ispunjavati uvjete prebivališta. Morate imati prebivalište u Australiji i morali ste:

- imati prebivalište u Australiji u razdoblju ili u razdobljima od ukupno 104 tjedna, ili
- biti izuzeti od ovih zahtjeva —na primjer, ako ste izbjeglica ili ste postali samohrani roditelj tijekom najnovijeg razdoblja prebivališta u Australiji.

Morate također zadovoljiti uvjete prebivališta na dan kada predate zahtjev i kroz cijelo vrijeme dok primate ovu vrstu plaćanja. Općenito gledajući, u Australiji morate biti fizički prisutni na dan kada predate zahtjev.

Ako ste živjeli ili radili u zemlji s kojom Australija ima međunarodni sporazum o socijalnom osiguranju, to vam može pomoći zadovoljiti ove uvjete prebivališta.

## Carer Allowance

Da biste imali pravo na Carer Allowance, morate zadovoljiti uvjete prebivališta. Vi i osoba za koju skrbite morate:

- imati prebivalište u Australiji
- i dalje ispunjavati uvjete prebivališta sve dok primate ovu vrstu plaćanja, i
- biti fizički prisutni u Australiji na dan kada predate zahtjev.

## Double Orphan Pension

Da biste imali pravo na Double Orphan Pension, morate ispunjavati uvjete prebivališta. Morate živjeti u Australiji i:

- imati australsko državljanstvo
- imati stalnu vizu
- imati special category visa, ili
- imati partner provisional, interdependency ili temporary protection visa.

Vaše dijete mora također ispunjavati uvjete prebivališta ili mora živjeti s vama.

Vi i dalje morate ispunjavati uvjete prebivališta sve dok primate ovu vrstu plaćanja.

Ako ste živjeli ili radili u zemlji s kojom Australija ima međunarodni sporazum o socijalnom osiguranju, to vam može pomoći zadovoljiti ove uvjete prebivališta.

Napomena: pozivi s kućnog telefona na '13' brojeve iz bilo kojeg dijela Australije naplaćuju se po fiksnoj stopi. Ta stopa se može razlikovati od cijene mjesnih poziva i može biti različita kod raznih pružatelja telefonskih usluga. Pozivi na '1800' brojeve s kućnog telefona su besplatni. Pozivi s javnih telefona i mobitela mogu se vremenski mjeriti i naplaćivati po višoj stopi.

# Residency requirements for family payments

Holders of partner provisional or interdependency visas may receive the payments listed below if they are temporarily outside Australia for an approved reason.

- Family Tax Benefit
- Parental Leave Pay or Dad and Partner Pay, or
- Double Orphan Pension.

However, holders of temporary protection visas cannot receive payments while outside Australia for any reason.

## Family Tax Benefit

To be eligible for Family Tax Benefit Part A and Part B, you must satisfy residency requirements. You must be living in Australia and:

- have Australian citizenship
- hold a permanent visa
- hold a special category visa, or
- hold a certain temporary visa type, for example a partner provisional, interdependency or temporary protection visa.

Your child must also meet the residency requirements or be living with you.

You must continue to meet the residency requirements for as long as you get this payment.

## Paid Parental Leave scheme

To be eligible for Parental Leave Pay you must satisfy the residency requirements from the date your child is born, or comes into your primary care, until the last day of your payment.

To be eligible for Dad and Partner Pay you must meet the residency requirements for each day you receive the payment.

When your child is born or comes into your primary care, you must be living in Australia and:

- have Australian citizenship
- hold a permanent visa
- hold a special category visa

- hold a certain temporary visa type, for example a partner provisional, interdependency or temporary protection visa.

## Parenting Payment

To be eligible for Parenting Payment, you must satisfy residency requirements. You must be an Australian resident and you must:

- have been an Australian resident for a period, or periods, that total 104 weeks, or
- be exempt from this requirement—for example, if you are a refugee or have become a single parent during your most recent period of Australian residence.

You must also meet residency requirements on the day you lodge your claim and for as long as you get this payment. Generally, you will need to be physically present in Australia on the day you lodge your claim.

If you have lived or worked in a country with which Australia has an international social security agreement, it may help you meet these residency requirements.

## Carer Allowance

To be eligible for Carer Allowance, you must satisfy residency requirements. You and the person you are caring for must:

- be Australian residents
- continue to meet the residency requirements for as long as you get this payment, and
- be physically present in Australia on the day you lodge your claim.

## Double Orphan Pension

To be eligible for Double Orphan Pension, you must satisfy residency requirements. You must be living in Australia and:

- have Australian citizenship
- hold a permanent visa
- hold a special category visa, or
- hold either a partner provisional, interdependency or temporary protection visa.

Your child must also meet the residency requirements or be living with you.

You must also continue to meet the residency requirements for as long as you get this payment.

If you have lived or worked in a country with which Australia has an international social security agreement, it may help you meet these residency requirements.
