Ustahili wa Parenting Payment

Parenting Payment inalipwa kwa mlezi husika wa mtoto. Ni mzazi mmoja tu au mlezi anayeweza kupokea malipo haya. Unaweza kustahili kwa ajili ya Parenting Payment kama mzazi, bibi au babu, mlezi wa kitambo au kama:

- Unaishi pekee na unatunza angalau mtoto mmoja mwenye umri wa chini ya miaka nane, au
- Una mpenzi na unatunza angalau mtoto mmoja mwenye umri wa chini ya miaka sita, na
- Mapato na mali zenu wote wewe na mpenzi wako (kama unaye) ziko chini ya kiasi fulani, na
- Unatimiza matakwa ya ukazi, na
- Unaweza kutimiza matakwa ya kujishughulisha kama inatakiwa.

Kiasi cha malipo cha Parenting Payment

Kiasi cha Parenting Payment unachokipata kinategemeana na hali ya familia. Viwango huwa vinarekebishwa tarehe 20 Machi na 20 Septemba kila mwaka. Kujua viwango vya sasa tembelea humanservices.gov.au/parentingpayment

Kipimo cha mapato na mali cha Parenting Payment

Kiasi cha Parenting Payment unachopata kinategemeana na kipato na mali zako za wewe na mpenzi wako (kama unaye).

Mali ni nyumba au umiliki wowote ulionao unaoweza kuwa sehemu au yote. Hii inajumuisha mali ulizonazo nje ya nchi ya Australia na madeni yanayowiwa kwako.

Kipimo cha kipato na mali hurekebishwa tarehe 20 Machi, 1 Julai na 20 Septemba kila mwaka. Kujua viwango vya sasa tembelea humanservices.gov.au/parentingpayment

Parenting Payment

Parenting Payment is income support for parents or guardians to help with the cost of raising children.

Eligibility for Parenting Payment

Parenting Payment is paid to the principal carer of a child. Only one parent or guardian can receive the payment. You may qualify for Parenting Payment as a parent, grandparent, or foster carer, if:

- you are single and care for at least one child aged less than eight, or
- you have a partner and care for at least one child aged less than six, and
- the income and assets of both you and your partner (if you have one) are below certain amounts, and
- you meet residence requirements, and
- you are able to meet participation requirements if needed.

Payment rates for Parenting Payment

The amount of Parenting Payment you get depends on your family situation. The rates are updated on 20 March and 20 September each year. For the latest rates visit humanservices.gov.au/parentingpayment

Income and assets tests for Parenting Payment

The amount of Parenting Payment you get depends on the income and assets of both you and your partner (if you have one).

An asset is any property or possession you own either partly or wholly. It includes assets held outside Australia and debts owing to you.

The income and assets tests are updated on 20 March, 1 July and 20 September each year. For the latest rates visit humanservices.gov.au/parentingpayment
